





...historically speaking, has been a late adopter of palliative medicine services. However, physician appreciation of the services we offer to improve the quality of care provided to patients and their families across multiple settings is rapidly increasing.

The opportunities to integrate palliative medicine into the outpatient setting are growing:

- incorporation of a palliative medicine clinic into the Sequoia Regional Cancer Center

- providing virtual palliative medicine consultations with patients currently being served by our Kaweah Health Home Based Palliative Medicine Service

- Expansion of palliative consultation services into Skilled Nursing Facilities.

- Earlier involvement of palliative services in the Emergency Department and ICU settings to ensure goal-concordant care in the acute care settings.
