Ambient Listening Pilot

- Ambulatory primary care focused
- 10 Practitioners
- Integrated with the Electronic Health Record
- Uses smartphone app and generative artificial intelligence (AI)
- Began late May and concludes in 4-6 weeks
- Findings to be reviewed
- Widespread deploymnt, if appropriate, will occur in FY26
- Anticipated benefits include reduced practitioner burnout, increased satisfaction, enhanced visit documentation, etc.
