 - Dr. Richard Pantera currently serves as the chair for the Institutional Review Board. The board members who participate on the committee are self-selected, non-paid volunteers that act as a safeguard to ensure the research that is conducted is ethically acceptable for human research. Majority of the research projects tend to be social and behavioral in nature which explores a person(s) behavior, beliefs, perceptions and attitudes through interviews to collect the necessary data. Most research projects are done within 1-2 years by the people who work at Kaweah Health while providing services to the community. Once the research project is

<u>Mission and Purpose:</u> The Academic Development Committee of the Board serves to strengthen our institutional pillar of empowering through education. Kaweah is a teaching health care organization and education is the foundation that enables Kaweah's teams to provide world-class care to our community in a constantly evolving medical climate. Members provide strategic guidance and support for the development and enduring success of our educational programs.

Specific Responsibilities: Review of GMEC oversight of GME including the Annual Institutional Review and annual program evaluations for all residency programs. Provide oversight of Annual American Society of Health System Pharmacists program reviews. Annual budget review and feasibility assessments for new & expanding programs. Collaborate with the Human Resources department and help with enterprise strategies for the education of our workforce. Monitor program retention and attrition along with compliance with ACGME, ABMS, CMS, ASHP and the Joint Commission. Strengths

- Strong faculty support:
 - Fellows had consistently high praise for our CAP attendings including Dr. Jaques, Dr. Pereyra, Dr. Brar, and others
 - Attendings offer a variety of treatment and teaching styles, with consistent focus on patient care and detailed/supportive supervision
 - Class of 2024: CAP retained two out of three graduates as faculty
 - Class of 2025: Kaweah Health retained two out of three graduates

- Diversity of clinical rotations:
 - Inpatient psychiatry (Central Star), ED/CL (Kaweah Medical Center), outpatient longitudinal clinic (Kaweah Lindsay x 2 years), outpatient pediatric consultations (Kaweah Exeter), multiple STRTPs serving unique high-risk populations (Courage to Change in Visalia, Success In Recovery in Exeter)
 - These are **above-and-beyond** what CAP fellowships are expected to provide
- Strong administrative support: Program coordinator has been a stable presence since last year, and is also our QI coordinator

Strengths (cont.)

- Focus on Clinical Skills and Achieving Independent Practice:
 - Direct observation by attendings, including remote and recorded psychotherapy sessions
 - Group psychotherapy supervision
 - Immediate feedback, individual discussions of short-/medium-/long-term goals
 - 100% pass rate on Child Psychiatry board exam
- Opportunities for Leadership Roles:
 - Academic/administrative: GMEC representation, Chiefship roles (Academic, Didactics QI), PEC.
 - Clinical: Leading groups at IOP and Inpatient (Central Star), running morning team meetings (Central Star)

- Consistently Strong Match Results:
 - No year has seen any positions go unfilled.
 - Reflects high quality experiences of residents/students
 - There is growing knowledge of the program nation/worldwide

Weaknesses

- Inpatient Psychiatry (Central Star):
 - EMR access delays
 - Workspace limitations (will improve at their new facility)
 - Commute to Fresno 4x / week
 - No patients younger than 12 years
- Longitudinal Outpatient Clinic (Lindsay):
 - Occasional staffing shortages/substitutions can result in accidental overbookings and interrupt clinic workflows
- Recruitment Challenges:
 - Fewer applications than more established programs
- Faculty Retention/Didactics:
 - Some faculty turnover this year due to changes in clinical sites and difficulties coordinating schedules for didactics lectures

Opportunities

- Growing the Program:
 - Expanding clinical rotations (Crisis Stabilization Unit, inpatient psychiatric consultation with Valley Children's Hospital)
 - o <u>Upcoming C&A hospital (21-bed)</u>, breaking ground July/August; will serve ages 4+, will replace Fresno rotation
 - Recruiting additional faculty, retaining graduated fellows

• Improving Psychotherapy Training: Continued development of the Psychotherapy elective, with new implementation of recordings and group supervision this year

- Streamlining Administrative Processes:
 - Addition of transitional period for incoming Academic Chief to facilitate improvements year-to-year

Threats

Delays in facility construction (Central Star, CSU) would limit training opportunities there

Delays in EMR/controlled prescribing privileges may restrict fellows' clinical autonomy

• Risk of unfilled fellow spots could affect supervision schedules/patient care, depending on rotation

• Fellow burnout/turnover due to clinical challenges/workload, resource limitations, transition to this area

• External factors, such as hospital or clinic operational challenges, could disrupt rotations and training experiences
