




Average Daily Census




Case Mix Index w/o Normal Newborns




Case Mix Index w/o Normal Newborns - All




Case Mix Medical w/o Normal Newborns




Case Mix Index Surgical w/o Normal Newborns




Average Discharges per Day




Observation Days






Cath Lab Patients (IP & OP)




Cath Lab (IP & OP) – 100 Min Units




Surgery (IP & OP) – 100 Min Units




Surgery Cases (IP & OP)






NICU - Avg Patients Per Day



Month of December - Budget Variances

- **Net Patient Service Revenue:** The unfavorable budget variance in net patient revenue of \$2.3M is primarily due to overall inpatient and outpatient volume variances.
- **Employee Benefits Expense:** The \$1.0M unfavorable variance is due to higher-than-expected claims experience in December related to the employee self-insured health plan.
- **Medical & Other Supplies Expense:** The \$1.5M unfavorable December variance is mainly due to pharmaceutical costs related to volumes in medical oncology and retail pharmacy .
- **Humana Cap Plan Expenses:** Humana third party expenses were \$760K (-25.2%) less than budgeted in December however, year-to-date remains much closer to budget (-1.7%).




Budget and Actual Fiscal Year 2026: Trended Operating Margin (000's)


Monthly Contract Labor Costs



Contract Labor Full Time Equivalents (FTEs)










Overtime as a % of Productive Hours








Medicare Managed Average Length of Stay








Medi-Cal and Medi-Cal Mged Average Length of Stay




Average Length of Stay Distribution
